TO WHOM IT MAY CONCERN

**DEMAND FOR PAYMENT FOR SERVICES RENDERED**

THIS LETTER serves as a notification of our intention to proceed with civil and criminal proceedings.

1. Shoot Smart Training Academy performed training and provided training manuals to your store: "The Gun Safe".
2. Shoot Smart Training Academy through Marksman Arms and Firearms Training concluded a Memorandum of Understanding with you for the use of your shooting range.
3. You have refused to pay our invoice which has made it impossible for our company to provide the service that your clients, and in essence our clients, due to your scandalous refusal to pay for our services which our clients have paid for.
4. Considering the above we have been left with no choice but to contact our clients informing them of your scandalous actions which includes two clients that are employed by SAPS at the office of the DFO.
5. We have also approached our attorneys and have instructed them to draft a notice of motion to begin recovery efforts against your company.
6. Furthermore, on 04 December 2025, you have refused our company to work and perform our duties citing that "Your range" is not available to our company.
7. Whilst this is amusing to hear I wish to remind you that the range is owned by Edco Services (Pty) Ltd in which the majority shareholder is The Tactical Nation (Pty) Ltd.
8. The Tactical Nation have informed me that you have ZERO authority to cancel or amend our MOU without the express permission of Hendrik Van Zyl.
9. It is therefore our demand that you refrain from any form of intimidation against ourselves, our management and most importantly of the clients who have PAID YOU expecting a service from our company.
10. Shoot Smart Training Academy has been provided evidence that the money paid by our clients to The Gun Safe has been used, amongst other items, to allegedly fund your personal lifestyle.
11. We are therefore seeking an urgent suspension of your bank account in order to recover the monies paid to you and in the alternative will approach the South African Police Services to lay criminal charges against you for fraudulently appropriating monies due to our company and paid by our clients in anticipation of services.

12. We hereby demand that the shooting range at The Gun Safe is available from **Monday 08 DECEMBER 2025** during normal business hours for our company to continue servicing clients whose money you have allegedly stolen.
13. We hereby demand full payment of our invoice attached and the immediate return of all manuals currently stored on your premises. We can no long trust you with the property of our company.
14. We inform you that your refusal to comply with our demands will result in our company advising our clients to join us in a lawsuit against your company and to lay criminal charges in their personal capacities against the Directors and Management of Edco Services (Pty) Ltd.
15. We do not need acknowledgement of acceptance of this letter but urge you to comply with our demands or expect a swift and unavoidable civil and criminal action.
